	Councillor Jordan left the meeting at 19:30. Councillor Howard (Vice Chair) chaired the meeting.					
	Councillor Mitchell advised that the Facebook page 'Abbotts Ann Village Community' is gaining interest and advised of conversation with residents of Cattle Lane with regards to 20's Plenty signage. The Clerk advised that permission needs to be sought from Hampshire County Council should the signs be placed upon existing street signs but residents can display a '20's plenty' sign on their own border or in the form of a wheelie bin sticker.					

Councillor Mitchell advised that residents have asked for reapplying for a mini roundabout at St John's Cross to assist with traffic flow. It was noted that the Clerk would contact Hampshire County Council to enquire as to the procedure required. Councillor Wallis advised that FOTAAS have tidied the fence around the bonfire at the Sportsfield but need to remove the bonfire ash once dry. 241106 To receive an update from Abbotts Ann Community Land Trust. Abbotts Ann Community Land Trust provided the following report: "Report to Abbotts Ann Parish Council as to the status of the project to build a mixed development of Affordable and market homes on land adjoining Abbotts Ann Primary School in Duck Street, Abbotts Ann. The Parish Council is aware that negotiations have been taking place over several months between our proposed development partner, Oxford Advanced Living (OAL), the land owner's agent and AACLT in an attempt to agree the terms of an agreement under which OAL would have the option to purchase the land and carry out the development in accordance with requirements agreed with AACLT. Unfortunately, it has not been possible to reach a successful conclusion and OAL have decided to withdraw from the project. AACLT are consequently in new discussions with the land owners to agree a way forward which we expect to include the procedure for the selection of a new mutually acceptable developer with similar obligations as to the quality of the development and wider benefits to the community. The mix of housing types is to be agreed and will have regard to the findings of the recent housing need survey of the village. The discussions with the land owner's advisors so far are encouraging and we hope to be able to share updates on progress within the coming months. 241107 To discuss progress on the new Bulbery facilities project. Noting the Parish Council cannot move forward without S106 contribution achieved from Abbotts Ann Community Land Trust. The Architect has commenced the initial outline planning stage and conducted an initial survey. A bat survey is required but cannot be conducted until the end of April / beginning of May which brings the project us to a natural pause. There is no adverse cost implications, the quote remains extant. As a Parish Council we can fund the pre application independently and not have to use FOTAAS funding. After outline planning permission, the Parish Council plan to move forward with the AACLT. Councillor Jordan reiterated that there is no risk to the Parish Councils in terms of what we have committed. From his position as Chair there is nothing to be gained by stopping the Architect from stopping the outline planning proposal. Thereafter, the Parish Council needs to conduct a deep review with the CLT. Councillor Jordan reiterated that the architect is tasked with designing the facilities within the budgetary limit as specified by the PC. It was NOTED that Councillors are content with the decision to proceed to outline planning and then meet with AACLT to see if progress can continue. 241108 To consider Bulbery playground options. Councillor Mitchell advised she has received one quote for playground equipment and pending another quote that would itemise items for individual purchase. Another company had provided a brochure so the Parish Council can cherry pick items and a quote will be provided.

Councillor Mitchell advised that she will endeavour to have quotes and summary for December meeting.

APPENDIX A

Environmental Portfolio Report for October 2024 – Councillor Heather Enotraths

The eighth round of path trimming completed in early October; on a recent path inspection 5 to 6 paths may need another trim in late November.

Our longest path called Green Lane has recently had the hedges trimmed back by the landowner which has made it much easy for walking.

Sewage

The PPPF quarterly meeting with Southern Water took place of the 14^{th of} October (copy of minutes are available on request) but I insert below for your information the section relevant to the valve issue at Mill Lane, and SW proposal how to overcome the problem to eliminate the spillage problem at Manor Farm.

10.Mill Lane Valve Update (FC) Action USW/PPF 23.2.1(c): Automation of Mill Lane Valves - ongoing FC said that the Playbook included operational protocols for the Mill Lane valves. John Heather (JH), Abbotts Ann PC reminded the meeting that there had been a problem with these valves and repeated spills at Manor Farm for some years. Did SW really understand what the problem was? KH answered yes, saying that the valves needed constant adjustment to keep them free of 'rag' i.e. the biggest culprit being wet wipes. FC outlined what SW were currently doing to address this problem [slide 33]. A company called Technology Ltd has been tasked with scoping an automated solution. MC commented that surely a battery or solar solution could be found. FC replied SLMs would be deployed by the end of October to monitor flow and provide data on trigger levels to help specify design parameters. A solution is expected early 2025 and will need to go through SW's established investment process. In the meantime, manual valve adjustments are being handed over to Flow Management Solutions (FMS) with GMcC making himself available to provide advice. MC asked what FMS do? LG replied that FMS's remit is to reduce tankers and disruption. JH asked who will be monitoring the valves? LG replied that Wayne Carter from FMS would have this responsibility and would be checking the valves 2 or 3 times a day from now on. JH said that whilst he appreciated that any spill spotted at the Manor Farm manhole chamber needed to be formally reported, he would also want to ensure FMS were informed [Subsequent to the meeting the PPPF has been given Nick Davies's contact details]. NM said that SW needed to think about streamlining the reporting of spills associated with these valves. JH asked whether SW would have installed valves here if they had been designing this section of the network from scratch? NM replied that wet wipes had not been invented when the sewer network was installed. He said that he had had a conversation with Ofwat earlier in the day with regard to banning wet wipes. He cited the success of banning plastic cotton buds and replacing them with cardboard - SW no longer experienced blockages caused by cotton buds. The erection of signs advising the public on how to report spills had been promised for many months. GMcC said that the signs would be installed tomorrow. [Subsequent to the meeting signs were erected 15.10.24 at Manor Farm and at the Mill Lane valves. Reflective material has also been applied to the concrete retaining posts at Manor Farm.]

To date at the time of writing this report there has been no spillage problems at Manor Farm reported in October. Ground water levels have been raising to record levels (see attached chart), but no tankers have been employed in October.


Highways and Public Footpaths.

Water Quality

Flow increases with water depth and both contribute to a healthier brook. This is shown by our water quality results - the chemicals we test for continue to be within acceptable parameters.

Kick Sampling

All sites show healthy invertebrate counts and as volunteers gain in experience we are beginning to find more e.g. caseless caddis lava. An elver (juvenile eel) was also caught at our Balksbury Park site this month. Common in the 1960's they are now critically endangered - so it's good to find evidence of their possible return in our brook.

Groundwater

GW exceeded 84 m at Clanville Gate on 21 October. This is the EA trigger level above which there is an increased risk of GW ingress in basements and sewer pipes. This is 2 weeks earlier than in 2023, no doubt accelerated by September's high rainfall. October's rainfall of 110 mm is closer to the monthly average and consequently GW levels are slowing. With a dry spell forecast levels may even start to fall. Find more details on our Groundwater page.



PMI monitors count the number of riverflies they find in eight key groups. From these numbers, an ARMI score is generated for that sample. Each site has a
trigger level, decided by the ecology contact from the statutory agency, which shows the minimum ARMI score that samples at that site should have if the river is
in acceptable ecological health. If the ARMI score of a sample is lower than the trigger level for that site, the monitor would then take a second sample to confirm
the trigger level breach. Once confirmed, the statutory agency is informed.

Borough Councillor Report

Cllr Maureen Flood and Cllr Susanne Hasselmann - November 2024

Borough Council action relating to Winter Fuel Payments

Finance cabinet member, Councillor Maureen Flood, and Liberal Democrat group leader, Councillor Neil Gwynne, put forward a motion at October's council meeting to substantially extend a local scheme that was set up in 2022 to help those pensioners struggling to cover their fuel costs.

Councillors showed unanimous support for the proposal to allocate £20,000 to the Test Valley Winter Fuel Payment Scheme, and a further £20,000 if required, to continue support for those of pensionable age in the borough who need assistance with paying their bills. In doing so, they estimate that this will help over 400 of the most vulnerable pensioner households in Test Valley.

They also agreed to write to the Chancellor of the Exchequer, urging a review of the decision to means-test the Winter Fuel Payment and to ask the government to ensure that vulnerable pensioners, particularly those who are just above the threshold for Pension Credit, are protected from fuel poverty.

Help us to make it easier to walk and cycle in Hampshire

Residents are being asked to help Hampshire County Council identify locations where physical barriers make it awkward and challenging to walk, cycle, wheel or scoot

The survey, which is open until Sunday 22 December 2024, seeks feedback to help pinpoint locations where there are obstacles, such as bollards, that make getting around difficult for people who have restricted mobility and need to use a mobility scooter, or for those pushing prams or riding cargo bikes for example.

Feedback can be provided via the online survey on the County Council's website.

We want people to tell us where there are:-

- Crossing points that are difficult to use because they don't have dropped kerbs and tactile paving
- Dropped kerbs which are not level with the road
- Staggered or chicane barriers
- Bollards placed too closely together
- Pavements made narrow by items such as guard railings, lampposts and signposts
- Misleading or unnecessary cycle signs and where new or additional cycle parking may be needed

Responses to the survey will help the County Council to secure the funding to make improvements to roads and pavements by providing evidence to support applications for Government funding, or in negotiating contributions from developers building new housing developments.
